We are called upon to ensure that economic development and the protection of human rights advance together. It requires close cooperation between governments, which provide enabling policy frameworks, and businesses, which integrate respect for human rights into their operations and supply chains.

Supported by UNDP and other partners, we can build a model of responsible leadership that strengthens both resilience and trust.
